5. All students must pay their semester fees in full within thirty (30) days from the date of invoice. The University reserves the right to suspend studies for students with outstanding fees.
6. AMU Bundle Programme Scholarship includes credit transfer fee adjustment. Students in this programme are not eligible for additional discounts, rebates, or scholarships at Diploma level.
7. Commitment Fees are set by the Student Recruitment Department and will be offset against the Tuition Fee upon successful registration, where applicable.
